



## Examples of incorrectly completed Initial bid forms

Applicants are reminded to carefully review the completed forms, in particular to contain all the necessary information, stamps and signatures.)

Applicant has to check available lots in category and especially spectrum caps in the Initial Bids should be taken into account (see Auction Rule 16)

- 2 x 30 MHz across the 800 and 900 MHz bands,
- 2 x 15 MHz in the 900 MHz band,
- 2 x 30 MHz in the 1800 MHz band,
- 2 x 105 MHz FDD across the 800 MHz, 900 MHz, 1800 MHz, 2100 MHz, and 2600 MHz bands, including existing holdings in the 2100 MHz FDD spectrum.

Below are some examples of incorrectly completed forms for the Initial bid:
